Commitment Requirements

The Commitment requires that by 2030

- Existing buildings reduce their energy consumption and eliminate or, where necessary, compensate for emissions from energy and refrigerants to net zero operating emissions, removing fossil fuel use as fast as practicable (where applicable).
- New developments and major renovations are built to be highly efficient, powered by renewables, with a maximum reduction in embodied carbon and compensation of all residual upfront emissions.

Signatories commit

- assets under direct control to reduce (and compensate where necessary) all operational carbon emissions by 2030
- new developments and major renovations under direct control to reduce and compensate (for residual upfront emissions) embodied carbon emissions by 2030

1 The Commitment is aimed at accelerating the transition to a decarbonised built environment, this means all buildings within the organisations' direct control are to be included in their portfolio and actioned as per the relevant requirements by 2030. 2 The Commitment advocates a reduction first approach in relation to both operational and embodied emissions as a core component to delivering decarbonisation of buildings. Whilst the Commitment does not set specific performance requirements, signatories are required to pursue maximum reductions as soon as possible, and to determine and implement an action roadmap that reduces the energy demand of buildings, improves energy efficiency and eliminate carbon emissions from operations. Signatories must also achieve maximum embodied carbon reductions for new developments and major renovations before pursuing high quality offsets to compensate for residual emissions.
